<sup>3</sup> Applicants that approach ALCUMUS Safecontractor Scheme/Avetta Assessed/Achilles BuildingConfidence will not be required to complete any of the SSIP Core Criteria H&S Element again, however they will be asked to complete a set of Specific Risk Profile Related questions as part of their application.
